RETENTION OF INFORMATION

We retain personal information according to legal requirements and professional standards:

Medical Records:

- Active patients: Maintained for duration of treatment relationship
- Adult patients: Minimum 10 years after last treatment
- Minor patients: Until age 21 or 10 years, whichever is longer
- South Carolina law and dental practice standards apply

Business Records:

- Billing and payment records: 7 years for tax purposes
- Insurance claims: As required by payers and regulations
- Website analytics: 2-3 years for business analysis
- Marketing communications: Until opt-out requested

Electronic Data:

- Practice management systems: As required for patient care
- Backup systems: Maintained according to data retention policies
- Security logs: Minimum 6 years for HIPAA compliance

CHILDREN'S PRIVACY

We provide dental services to patients of all ages at both practice locations. For patients under 18:

- We obtain appropriate consent from parents or guardians
- Parents/guardians have access to their child's information
- We comply with additional privacy protections for minors
- Age-appropriate communication methods are used
